FIRST: Article I of the articles of incorporation of the corporation is amended to read as follows:

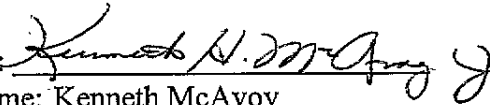
ARTICLE I - NAME
