Articles of Incorporation of Antani, Inc.

ARTICLE I-NAME

The name of the corporation is Antani, Inc.

ARTICLE II-DURATION

The corporation shall have perpetual existence, unless sconer dissolved in accordance with the laws of the State of Florida.
