

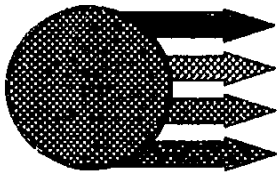

ARTICLES OF INCORPORATION  
OF  
L & G SYSTEMS, INC.

ARTICLE ONE

The name of the corporation is L & G Systems, Inc. The principal address and mailing address of the corporation is 3146 Fiesta Drive, Dunedin, Florida 34698.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE
