**ARTICLE ONE
NAME**

The term of existence of the corporation is perpetual.



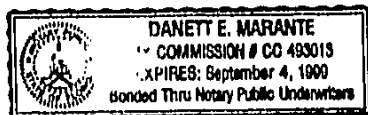
