ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE - NAME AND ADDRESS

The name of the corporation shall be **Reginald G. Stambaugh, P.A.** The principal place of business of this corporation shall be **1400 Centrepark Boulevard, Suite 860, West Palm Beach, FL 33401.**

ARTICLE TWO - DURATION

The term of the corporation's existence is perpetual.

ARTICLE THREE - PURPOSE

The corporation's purpose is to engage in and to transact any and all business for which corporations may be incorporated under the Florida General Corporation Act, **LAW PRACTICE.**

ARTICLE FOUR - CAPITAL STOCK






