**ARTICLES OF INCORPORATION  
OF  
T-LOGIC SYSTEMS INC.**

The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation shall be T-Logic Systems Inc.

**ARTICLE II - COMMENCEMENT & DURATION**

The corporation shall commence its existence on filing of its articles and shall exist perpetually unless sooner dissolved according to law.

**ARTICLE III - ADDRESS**

**ARTICLE IV - STATED CAPITAL**

The corporation is authorized to issue the following capital stock:

**ARTICLE IX - AMENDMENTS TO ARTICLES**

The Directors shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.
