Article I - Name and Address

The name of this corporation is **JESSICA NEWTON ENTERPRISES, INC.** with its principal address as **21 HEATHER COVE DRIVE, BOYNTON BEACH, FLORIDA 33462.**

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose and Powers


