#### **ARTICLE 1 - NAME**

The Name of the corporation shall be: STAR TRANSMISSION, INC.

### **ARTICLE 2 - DURATION**

This corporation shall exist in perpetuity.

#### **ARTICLE 3 - PURPOSE**

General nature of the business and the object and purposes proposed to be transacted and carried on, are to do any and all of the things mentioned herein, as fully and to the same extent as natural personas might or cod, viz. Engage in any business or activity permitted under the laws of the United States and the State of Florida, including but not to the following:

b) To sell at wholesale and retail and to deal in any manner whatsoever in all types and descriptions of property; to do all things and engage in all activities necessary and proper isoidestal to the business of investing in and developing real estate.

- c) To conduct and carry on the business of builders and contractors for the purpose of building, emeting, altering, repairing or doing any other work in connection with any said all classes of building and improvements of any kind and antere, whatsoever, including the building, rebuilding, alteration, specing or improvement of houses, factories, buildings, works or erections of every kind and description whatsoever, including the location, laying out and constructing of roads, avenues, docks, slips, severs, bridges, wells, wells, canals, railroads or street railways, power plants and generally in all cleases of building exections and works, both public and private, or integral parts thereof, and generally to do and perform any and all works as builders and contractes, and with that end in view to solicit; obtain, make, perform and carry out contracts covering the building and contracting business and the work connected therewith.
- d) To manufacture, buy, sell, trade, and deal in all and every kind of material product, manufactured and unmanufactured, iron, steel, wood, brick, coment, granite, stone and other products and materials, including the quarrying of stone, to buy, acquire, hold, use, copley, mortgage, convey, lease, and dispose of patent rights, letter,

patent processes, devices, inventions, trademarks, formulas, goodwill, and other rights; to advances from time to time on bonds accured by mortgage for future advances on real estate, but nothing herein set forth shall give or be construed to give said corporation any banking powers.

c) To purchase, take and lease, or in exchange, hire or otherwise acquire any real or personal property, rights or privileges suitable or convenient for any of the purposes of this business, and to purchase, acquire, creet and construct, make improvement of building or machinery, stores or works, insofar as the same may be appurement to or useful for the conduct of the business as above specified, but only to the extent to which the company may be authorized by the statutes under which it is organized.

#### **ARTICLE 4 - CAPITAL STOCK**

This corporation is authorized to issue 1,000 shares of One Dollar (\$1.00) par value common stock.

#### ARTICLE 5 - PREEMPTIVE RIGHTS
