**ARTICLES OF INCORPORATION  
OF

I, WILLIAM F. YOUNG, the undersigned incorporator, hereby make, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

**ARTICLE I**

NAME:

The name of this Corporation shall be: MORE THAN CARPET, INC.

**NATURE OF BUSINESS** The general purpose for which this Corporation is organized is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

The Corporation shall exist perpetually unless dissolved according to law.

#### ARTICLE V

##### **INITIAL PRINCIPAL OFFICE, MAILING ADDRESS AND**

### SPECIAL PROVISIONS

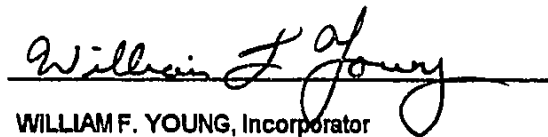

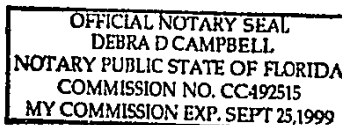
