The undersigned incorporators, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be INTER WEB DATA CORP. Its mailing address shall be 295 Plantation Hill Road, Gulf Breeze, Florida 32561.

ARTICLE II - GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

1. To develop and market, both wholesale and retail, software applications for use on the world wide web.
2. It is intended that this corporation may conduct and transact any business lawfully authorized and not prohibited by Chapter 607, Florida Statutes, as the same may be from time to time amended. Provided, however, and notwithstanding the generality of the foregoing, this corporation is not to conduct a banking, safe deposit, trust, insurance, surety, express, building and loan association, fraternal benefit society, state fair or exposition business.

### ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock this corporation is authorized to issue and have outstanding initially is One Thousand (1,000) shares of \$1.00 par value common stock. The Board of Directors shall be empowered to increase or decrease from time to time the number and classes of shares of stock authorized to be issued and outstanding.

### ARTICLE IV - DATE OF COMMENCEMENT AND TERM OF EXISTENCE

This corporation shall commence existence on September 20, 1997, and shall exist perpetually.

### ARTICLE V - INITIAL REGISTERED AGENT AND REGISTERED OFFICE

The initial street address of the registered office of this corporation in the State of Florida will be 295 Plantation Hill Road, Gulf Breeze, Santa Rosa County, Florida 32561. The Board of Directors may from time to time move the registered office to any other address in the State of Florida. The name of the initial registered agent of the corporation is Gary Little and he can be served with legal process on behalf of the corporation at 295 Plantation Hill Road, Gulf Breeze, Santa Rosa County, Florida 32534. The Board of Directors may from time to time designate a new registered agent.

### ARTICLE VI - BOARD OF DIRECTORS

A. The initial number of directors of this corporation shall be Two (2).

B. The number of directors may be increased or diminished from time to time by bylaws adopted by the stockholders, but shall never be less than one.

C. The names and street addresses of the initial members of the Board of Directors, each to hold office until the first annual meeting of the shareholders or thereafter until their successors are elected or appointed and have qualified are:

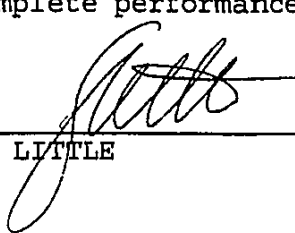
