**ARTICLES OF INCORPORATION
OF
TSCPR FLORIDA, INC.**

ARTICLE I - NAME

The name of this corporation is TSCPR Florida, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on September 17, 1997.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 7,500 shares of one penny (\$.01) par value common stock, which shall be designated "Common Shares."

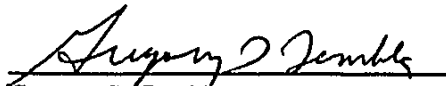

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, in accordance with the provisions of the Florida General Corporation Act.

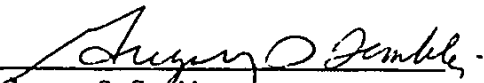
