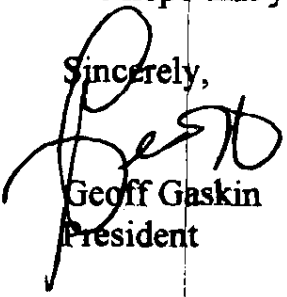
Attention: Michelle in Corporate Reinstatement
