ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit since ithe laws SIATE Florida, adopts the following Articles of Incorporation:

TALLAHASSEE. FLORIDA

Article I Name

Section 1.1. Name. The name of this corporation shall be Green Shades Accounting Software, Inc.

Article II Principal Office and Mailing Address

<u>Section 2.1</u>. <u>Principal Office and Mailing Address</u>. The principal place of business and mailing address of this corporation shall be 2724 College Street, Suite 7, Jacksonville, Florida 32205.

Article III Capital Stock
