
ARTICLE XIII

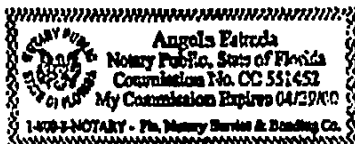
