ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF  
FLORIDA FIRE EQUIPMENT CORP.

Pursuant to Section 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of Florida Fire Equipment Corp. (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is Florida Fire Equipment Corp.


SECOND: The Articles of Incorporation are hereby amended to delete Article I in its entirety and replace it with the following:

"ARTICLE I - NAME

The name of the corporation is Fire Fighters Equipment Company, and the principal address of the Corporation is 3038 Lenox Avenue, Jacksonville, Florida 32254."

THIRD: The foregoing amendment was adopted by written consent of the shareholders and directors of the Corporation, constituting a sufficient number of votes for the amendment to be approved in accordance with Sections 607.0821 and 607.0704 of the Florida Statutes, on JUNE 23<sup>rd</sup>, 1998.
