Florida as follows:

ARTICLE I.

Name

The name of this corporation is MEDITERRANEAN ANTIQUES AND ARCHITECTURAL ELEMENTS, INC. The mailing address of the corporation is 1515 Ringling Blvd., Suite 1000, Sarasota, Florida 34236.

ARTICLE II.

Term of Existence

The date when corporate existence shall commence shall be the date of filing of these articles with the Department of State, and the corporation shall have perpetual existence thereafter.

ARTICLE III.

Nature of Business
