

The undersigned incorporators under these Articles of Incorporation in
order to form a corporation under the laws of Florida, hereby certify:

ARTICLE 1 - The name of the corporation is:

EXPRESSLINE SERVICES, CORP.

ARTICLE 2 - This corporation is to exist perpetually.

ARTICLE 3 - The general purposes for which this corporation is
organized is:

(a) To engage in the business of freight forwarding, transportation and movement of cargo; furnishing every kind of support service to common carriers, including, but not limited to administration, office personnel, cargo handling, carrier maintenance, ticket handling, cargo and passenger ticket sales and promotion, import and export documentation and services, custom documentation and any other service in connection with the transportation business, both passenger and cargo, both at wholesale or retail, as principal or agent, and any other business in connection therewith.

(b) To do anything which a corporation may lawfully do under the laws of the State of Florida.

ARTICLE 4- The street and mailing address of the initial principal office of the corporation is: 1424 N.W. 82nd Avenue, Miami, Florida 33126.

ARTICLE 5- The aggregate number of shares of stock which the corporation shall have authority to issue is 50 shares of no par value, capital stock.

number of directors, but shall never be less than one. The names and addresses of the members of the first Board of Directors are:




