ARTICLES OF INCORPORATION
OF
DWYER CONSTRUCTION, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE I

The name of this corporation shall be DWYER CONSTRUCTION, INC., hereinafter referred to as the "corporation".
