WE, the undersigned incorporators, each a natural person competent to contract, hereby associate ourselves together to formand establish a corporation NOT FOR PROFIT under the laws of the State of Florida.

FIRST: The name of the corporation is ANNA MILLER FOUNDATION, INC.

SECOND: The location of its principal place of business in this State is 759 Fernwood Road, Key Biscayne, Florida 33149.

THIRD: The location of its registered agent in this State is 759 Fernwood Road, Key Biscayne, Florida 33149.

FOURTH: The name of the registered agent of this corporation is:

DIANE LEE O'NEILL

FIFTH: This corporation is organized NOT FOR PROFIT and the object, and purposes to be transacted and carried on are:

To form a group of American and Jamaican citizens to help feed and educate the young destitute and unfortunate children of Jamaica.

SIXTH: The members of the corporation shall be those persons of good moral character and deportment whose applications are approved by a Board of Admissions.

SEVENTH: The private property of the members of this corporation shall not be liable for its corporation debts.

EIGHTH: In the event of the dissolution of this corporation or in the event it shall cease to carry out the objects and purposes herein set forth, all the business property, and assets of the corporation shall go, and be distributed to such non-profitable and charitable corporation, municipal corporations as may be selected by the board of directors of this corporation so that

the business property and assets of this corporation shall in that event be used for and devoted to, the purposes of carrying on another charitable organization, and in no event shall any of said assets or property in the event of dissolution thereof, go or be distributed to members either for reimbursement of any sum subscribed, donated, or contrubuted by such members or for any other such purpose, it being the intent that in the event for the dissolution of this corporation, or upon ceasing to carry out the objects and purposes herein set forth the property and assets there owned by the corporation shall be donated to the carrying on the function and purposes of another charitable organization as the board of directors shall determine and direct.

NINTH: The affairs of the corporation are to be managed by a board of directors in elections to be held every two years.

TENTH: The general officers of the corporation shall be a president, treasurer and a vice-president, secretary, one person can hold more than one office.
