The undersigned incorporator hereby forms a corporation under Chapter 607, Florida Statutes, as follows:

Article I-Name

The name of the corporation shall be Wood Construction Unlimited, Inc., and the principal office and the mailing address of the corporation shall be 40 Weber Boulevard N., Naples, Fl 34120.

Article II-Nature of Business

The corporation is authorized to conduct any activities as are permitted under applicable Florida Statutes.
