ARTICLE I-NAME

The name of this corporation is

ARTICLE XI-AMENDMENTS

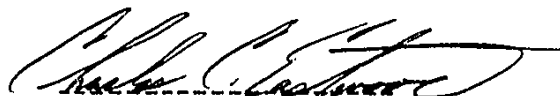
