The undersigned subscribers, being natural persons competent to contract, and for the purpose of forming a corporation under the laws of State of Florida, hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation shall be

AMERICA INTERNATIONAL R R, INC.

ARTICLE TWO

The corporation shall have perpetual existence unless sooner dissolved according to the law, and shall commence corporate existence upon the filing of these Articles by the Department of State.

ARTICLE THREE

The corporation is organized for the purpose of transacting, conducting, carrying on, operating and engaging in real and personal property and all things subsidiary, necessary, ancillary and convenient for carrying out and into effect the purpose and objects of the corporation, and in respect thereto, and to transact and engage in any activity or business permitted under the Laws of the State of Florida, and of the United States.

ARTICLE FOUR

The corporation is authorized to issue One Thousand (1,000) shares of One Dollar (\$ 1.00) par value common stock which shall be designated " Common Stock ".

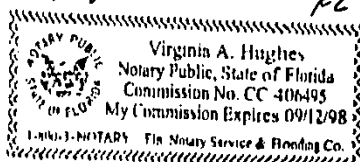
