# ARTICLES OF INCORPORATION OF J. Higgins & Associates, Inc.

These Articles of Incorporation are executed and acknowledged by that under the Florida incorporation for profit under the Florida General Corporation Act and sets forth that:

### ARTICLE I Name

The name of the corporation is J. Higgins & Associates, Inc. The mailing address of J. Higgins & Associates, Inc. is 613 Longmeadow Circle, Longwood, Florida 32779.

# ARTICLE II Purpose

The general purpose or purposes for which this corporation is organized is to engage in the transaction of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

# ARTICLE III Capital
