**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF ICS/TROPICAL, INC., A FLORIDA CORPORATION**

In accordance with the terms of Section 607.1006 of the Florida Business Corporation Act, and pursuant to a joint unanimous written consent of the shareholders and board of directors of the Corporation entered into as of January 1, 2001, ICS Tropical, Inc., a Florida corporation (the "Corporation"), hereby adopts the following amendment to its Articles of Incorporation:

Article I is hereby amended to read as follows:

**ARTICLE I**

**NAME**

The name of the Corporation is APA Wireless Technologies, Inc.

Article V is hereby amended as follows:

**ARTICLE V.**

**CAPITAL STOCK**

The Corporation shall have the authority to issue a maximum of 75,000,000 shares of Common Stock having no par value.
