ARTICLE I

The name of the corporation is ALBERT FERRER, D.C., P.A.

ARTICLE II

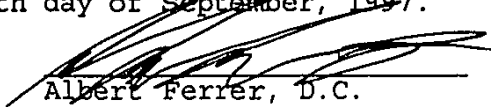
