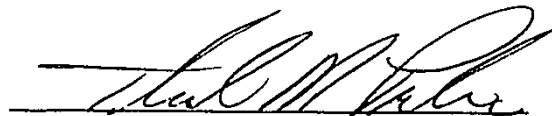
CERTIFICATE OF DESIGNATION
