**Article I. Corporate Name and Initial Corporate Address**

The name of this corporation is **Cool Rae's Productions, Inc.**, and the initial corporate address is 11212 Middle Beach Road, Panama City Beach, Florida 32407.

**Article II. Nature of Business and Powers**

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

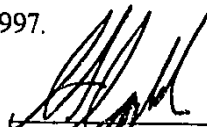

#### Article IX. Preemptive Rights

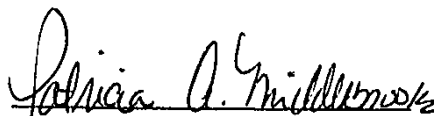

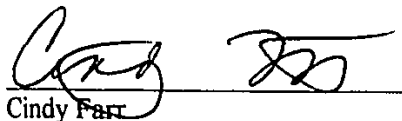
