THE UNDERSIGNED subscriber (s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

THE NAME of this Corporation is:      **TURBOSOURCE INC.**

**ARTICLE II. NATURE**

THE GENERAL NATURE of the business to be transacted by this Corporation shall be: Import and Export, General Mechanics, Wholesale, resale, retail, new, used and rebuilt turbo parts and turbochargers, purchase and sales of new and used aircraft parts, sales and service of fuel injection parts, diesel and gasoline.

- A. To engage in every aspect and phase of the business of operating a business with the above mentioned characteristics.
- B. To conduct business in, have one or more offices in, and buy, hold mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses, in the State of Florida and in all other States and Countries.

To guarantee, endorse, purchase, hold, sell, transfer mortgage, pledge or otherwise acquire or dispose of the capital stock of, or any bonds, securities or other evidence of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owners of such stock exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

F. To manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, assign, and transfer or otherwise dispose of, to invest, trade, deal in and deal with, goods, wares and merchandise and real and personal property of every class and description.


