OF

ROADMASTER DRIVERS SCHOOL OF JACKSONVILLE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation.
