OFFICERS AND DIRECTORS

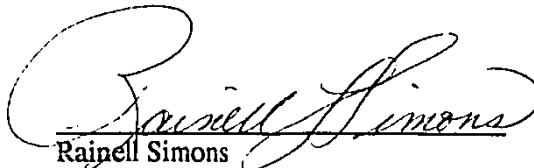

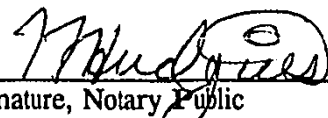
