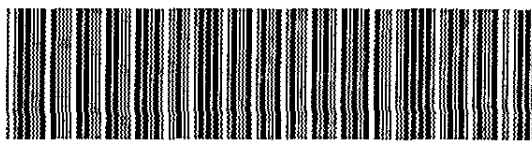

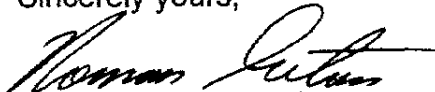

Article I of the Articles of Incorporation of McSPADDEN INTERESTS, INC. is hereby amended as hereinafter provided. The Corporation is filing these Articles of Amendment to its Articles of Incorporation pursuant to Florida Statute Section 607.1006.

1. The name of the corporation prior to the effective date of this Amendment is McSPADDEN INTERESTS, INC. Article I of the Articles of Incorporation of McSPADDEN INTERESTS, INC. is hereby amended to read as follows:

"ARTICLE I

The name of the Corporation is **BRUMBERG CONSULTING, INC"**.

2.
