# ARTICLE X LIMITATIONS ON CORPORATE STOCK

- No shareholder can enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of his stock.
- 2. If any officer, shareholder, agent or employee of this corporation who has been rendering professional services to the public becomes legally disqualified to render such services within the State of Florida, or is elected to a services within the State of Florida, or is elected to a public office or accepts employment that, pursuant to existing public office or accepts employment apon his continued law, places restrictions or limitations upon his continued rendering of such professional services, he shall sever all rendering of such professional interest in the corporation.
