Articles of Incorporation

of

JUDY B. OVERTON, PROFESSIONAL ASSOCIATION

The undersigned incorporator, who is licensed to practice as a real estate salesperson in the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and does hereby adopt the following Articles of Incorporation:

ARTICLE I Name of Corporation

The name of this corporation is JUDY B. OVERTON, PROFESSIONAL ASSOCIATION.

ARTICLE II

Principal Office and Mailing Address
