## ARTICLES OF INCORPORATION

### P R PRODUCTIONS INTERNATIONAL, INC.

The undersigned incorporator hereby forms a corporation under chapter 607 of the laws of the State of Florida.

#### ARTICLE 1- NAME

The name of this corporation is P R PRODUCTIONS INTERNATIONAL, INC.

#### ARTICLE 2- PRINCIPAL OFFICE

The street address of the initial principal office of the corporation shall be: 1043 Hillsboro mile # 8c, Hillsboro beach, Fl 33062

#### ARTICLE 3- PURPOSE

The corporation is organized for the purpose of productions or in any activity that is lawful in this state or the United States.

#### ARTICLE 4- CAPITAL STOCK

This corporation is authorized to issue one thousand(1,000) shares of one dollar(\$1.00) par value common stock which shall be designated as "common shares".




