

I, Jerry D. Gray, am the new accountant for C & P Kiddie Express. My services were retained to act as business consultant, also. I am POA representing this corporation.

C & P Kiddie Express, seemingly, did not file the required Annual Report timely. Therefore, your Department dissolved this corporation. After discussing this matter thoroughly with the officers, employees, and representatives of this corporation, we determined that the notice to file was not received, causing this failure to file. We, further, concluded that the only person(s) that may have received this vital information is the company that prepared and filed the original corporation application and paper work. They are, also, listed as agent. We are checking this possibility further. In any case, those responsible for daily operation and for filing the renewal did not receive these necessary and vital forms. It appears that the corporation is not responsible this failure to file.

On January 14th, 1999, I spoke with Shawn of this Department's Reinstatement Division. He explained that under these circumstances that the Department will evaluate this situation and possibly exempt the \$750.00 reinstatement fees. This is a newly formed small corporation and really can not afford this undue penalty. We, also, offer in evidence the sworn statement from the key persons responsible for filing these reports. See attached. **Therefore, we are requesting that all penalties relate to this matter be exempted.**
