ARTICLE I - NAME

The name of this corporation is JASH INTERNATIONAL, INC. and the principal office address is: 2500 SW 107 Avenue #34, , Miami, FL 33165.

ARTICLE II - DURATION

This corporation shall have perpetual existence unless sooner dissolved according to the law.

ARTICLE III - PURPOSE

This corporation is organized to engage in the business of import and export; consultancy and allied services; buying, selling and distribution of groceries, food, and general merchandise items; operating grocery stores; in conformity with the existing laws, municipal rules and regulations or such as may be hereafter enacted; and to engage in any other lawful business from time to time.


