**ARTICLES OF INCORPORATION
OF
SWISS-MIAMI HOLDINGS, INC.**

(a Florida corporation)

In compliance with Chapter 607 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purposes of organizing a business corporation.

ARTICLE I

NAME

The name of the corporation (the "Corporation") is:

SWISS-MIAMI HOLDINGS, INC.

ARTICLE II

PURPOSE

The purpose of the Corporation shall be to conduct any lawful activity.

ARTICLE III

PRINCIPAL ADDRESS

The address of the principal office of the Corporation is 815 NW 57th Avenue, Suite 144, Miami, Florida 33126.

ARTICLE IV

CAPITAL STOCK

The maximum number of shares which the Corporation is authorized to issue is 10,000, all of which shall be common stock, and which shall have a par value of \$.01 per share.
