ARTICLE I: NAME

The name of this corporation is **MEDIA COLLECTIONS**, INC. The mailing address of the corporation is 2901 Clintmore Road, Suite 103, Boca Raton, FLorida 33496.

ARTICLE II: DURATION

This corporation shall have perpetual existence.

ARTICLE III: PURPOSE
