**ARTICLES OF INCORPORATION OF
COUNTY LINE UNDERWRITERS, INC.**

Article I: Name

The name of the corporation is: County Line Underwriters, Inc.

Article II: Purpose

The corporation may engage in the business of operating an Ameriway Insurance Franchise; provided however, the corporation may also invest its funds in real estate, mortgages, stocks, bonds or any other type of investment and may own real or personal property.

Article III: Stock

The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1,000 shares of common capital stock of par value of \$1.00 per share. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of transfer or levy on such shares.

Article IV: Existence

Article XI: Restrictions on Transfer
