**ARTICLE I.  
SHEL-CON EXPRESS, INC.**

The name of this corporation is Shel-Con Express, Inc.

**ARTICLE II.**

The address of the principal office of the Corporation, is

**ARTICLE III.  
DURATION**

The corporation shall have perpetual existence, commencing  
on the date of the execution and acknowledgment of these  
Articles or upon filing.

**ARTICLE IV.  
PURPOSE**

The corporation is organized for the purpose of transacting  
any and all lawful business.

**ARTICLE V.  
NUMBER AND CLASS OF STOCK**

The corporation is authorized to issue one class of stock  
which shall consist of 100 shares of \$1.00 par value common  
stock, and which shall be designated "common shares".

## **ARTICLE VI. PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of the corporation of the same kind, class, or series as that which he holds, shall have the right to purchase his pro rata shares thereof, (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

## **ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of the corporation is 5900 Shirley Street, Naples, FL 34109, and the name of the initial registered agent of the corporation at that address is Michelle M. Rivera. The officers may from time to time select and so communicate by appropriate notice to the Department of State, another registered office or registered agent or both.

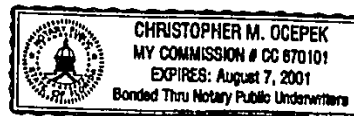
