I, the undersigned subscriber to these Articles of Incorporation, do hereby make, subscribe, acknowledge and file these Articles for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be Alpha Systems At Pensacola, Inc.

ARTICLE II

This corporation is organized for the purpose of transacting any and all lawful business, both within and without the state of Florida. Additionally, the general nature of the business or businesses to be transacted shall be:

- (a) To conduct, maintain, operate and to do business as a real estate developer and to serve the general public as such.
- (b) To own real and personal property, and to construct, improve, maintain, operate, remodel and generally deal with and in the same, and any appurtenances convenient, desirable or necessary in the conduct and operation of the lawful business of the corporation.
- (c) To do all and everything necessary or proper for the accomplishment of the objectives and purposes of the corporation, as determined by the corporation's Board of Directors in its discretion and consistent with the laws of the State of Florida, or as necessary or incidental to the protection and benefit of the corporation, and in general to carry out any lawful business, regardless of whether such business is similar in nature to the objects as set forth herein, and in any part of the world, either as principal, agent, contractor, or otherwise, and either alone or in conjunction with any other persons, firm, associations,

ARTICLE III

This corporation is authorized to issue Ten Thousand (10,000) shares of common stock, each share of the par value of Ten Dollars (\$10.00). No shares without nominal or par value shall be issued.

ARTICLE IV

The corporation shall have perpetual existence, commencing on the date of filing of these Articles of Incorporation in the Office of the Secretary of State of the State of Florida.

ARTICLE V

This corporation shall have one director initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the corporation, but the number of directors of the corporation shall not be less than one nor more than seven.
