The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: WASH LAND, INC.

Article 2. Address of the Principal Office. The address of the corporation is Post Office Box 3704, St. Augustine, Florida 32085.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:


