ARTICLES OF INCORPORATION FOR CURTRON FUN & GAMES COMPANY, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is CURTRON FUN & GAMES COMPANY, INC.

ARTICLE II: DURATION:

This corporation shall exist perpetually, commencing on the date of the filing of these Articles, unless dissolved according to law.
