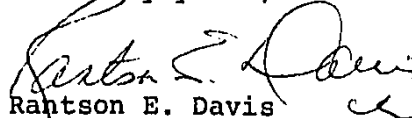

ARTICLES OF INCORPORATION  
OF  
AMERICAN TAXI SERVICE, INC.

ARTICLE I. NAME

The name of this corporation is AMERICAN TAXI SERVICE, INC., at 2301 N.E. 17th Place, Suite 203, Ocala, Florida 34470.

ARTICLE II. DURATION

This corporation shall begin its existence on the 1st day of October, 1997. The period of its duration is perpetual.

ARTICLE III PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is:

SEVEN THOUSAND FIVE HUNDRED (7,500) shares of Common Stock having a Nominal or Par Value of ONE DOLLAR (\$1.00) per share.

ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he/she already holds, shall have the right

to purchase his/her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

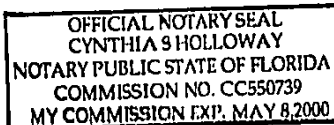
