The undersigned, acting as Incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I. CORPORATE NAME

The name of this corporation is Tara Financial Group, Inc..

ARTICLE II. PRINCIPAL OFFICE

The name and address of the initial Registered Agent are Walter E. Apple, 2425 East Commercial Boulevard, Fort Lauderdale FL 33308.


ARTICLE V. INCORPORATOR
