Articles of Incorporation

THE UNDERSIGNED, desiring to incorporate a corporation under the provisions of the Florida Corporation Act does hereby certify:

1. The name of the Corporation is ADC Administrative Services, Inc.
2. The term for which the Corporation is to exist is perpetual.
3. The general nature of the business to be transacted by the Corporation shall be to engage in any lawful act permitted under the laws of the United States of America and of the State of Florida, as limited by the provisions of the Florida Corporation Act.
4. The aggregate number of shares of capital stock which the Corporation shall have the authority to issue is ten thousand (10,000) shares of common stock having a par value of one dollar (1.00) each.
5. The initial principal office of the Corporation shall be located at 10777 SW 60 Avenue, Miami, Florida 33156

6. The initial Board of Directors shall be comprised of two (2) members. The numbers of Directors may be either increased or diminished from time to time by the Bylaws but shall never be less than one (1).

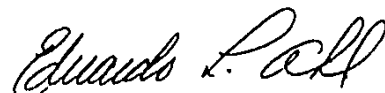
