**CERTIFICATE OF INCORPORATION
MAIN STREET FLORIST, INC.**

1. **Name.**

The name of the Corporation is Main Street Florist, Inc.

2. **Principal Office and Registered Agent.**

Its registered office and principal office in the State of Florida is 109 Woodburn Court, Safety Harbor, Florida 34695. The name of its registered agent at such address is Donald E. Thornburg.

3. **Purposes.**

The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.

4. **Capital Stock.**

The total number of shares of capital stock that the Corporation shall have authority to issue is 10,000, all of which are to be common stock with no par value.

5. **Incorporator, and Initial Officers and Directors.**

If such date is not within five business days of the date of filing, then the corporation's existence will commence on the date these articles are filed by the Department of State of the State of Florida.

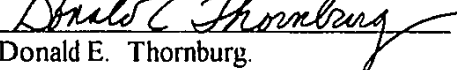
