# ARTICLES OF INCORPORATION

# **ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is USA GAMING CONSULTANTS CORPORATION, and its principal place of business shall be located at 647 E. Dania Beach Blvd., Dania, Florida 33004.

# **ARTICLE II - DURATION**
