ARTICLES OF INCORPORATION

OF

ORION INTERNATIONAL SHOPPING CENTERS CORPORATION

ARTICLE I - NAME

The name of this corporation is Orion International Shopping Centers Corporation

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by this corporation shall be any and all activities permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV - CAPITAL STOCK
