**ARTICLES OF INCORPORATION
OF
RJM TRUCKING, INC.**

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, DOES HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I

THE NAME OF THIS CORPORATION IS RJM TRUCKING, INC.

ARTICLE II

THE DURATION OF THIS CORPORATION SHALL BE PERPETUAL.

ARTICLE III

THE CORPORATION MAY ENGAGE IN ANY ACTIVITY OR BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATES AND THE STATE OF FLORIDA.

ARTICLE IV

THE AMOUNT OF CAPITAL STOCK OF THIS CORPORATION SHALL BE ONE HUNDRED SHARES (100) AT ONE DOLLAR (\$1.00) PER SHARE PAR VALUE STOCK, WHICH SUCH STOCK SHALL BE NON-ASSESSABLE TO BE HELD, SOLD AND PAID FOR AT SUCH TIME AND IN SUCH MANNER AS THE BOARD OF DIRECTORS MAY, FROM TIME TO TIME, DETERMINE, ALL OF THE CAPITAL STOCK SHALL BE COMMON STOCK.

ARTICLE V

THE CORPORATION SHALL COMMENCE BUSINESS ON FILING WITH THE SECRETARY OF STATE.

ARTICLE VI

THE PRINCIPAL PLACE FOR THE TRANSACTION OF ITS BUSINESS SHALL BE 406 EAST NORTH SHORE DRIVE - FORT MYERS - FLORIDA - 33917. THAT SAID CORPORATION SHALL HAVE THE AUTHORITY TO DO BUSINESS AT SUCH OTHER PLACE OR PLACES WITHIN OR WITHOUT THE STATE OF FLORIDA, AS THE CORPORATION MAY BE RESOLUTION DESIGNATE.

THE OFFICERS BY WHOM THE BUSINESS OF SAID CORPORATION SHALL BE CONDUCTED SHALL BE PRESIDENT, WHO SHALL BE A DIRECTOR, A VICE-PRESIDENT, A SECRETARY AND A TREASURER AND SUCH OTHER OFFICERS AND AGENTS AND DIRECTORS, WHO SHALL BE CHOSEN IN SUCH MANNER, HOLD THEIR OFFICE FOR SUCH TERM AND HAVE SUCH POWERS AND DUTIES AS MAY BE PRESCRIBED BY THE BY-LAWS AS DETERMINED BY THE BOARD OF DIRECTORS. EACH SHAREHOLDER, UPON THE SALE FOR CASH OF ANY NEW STOCK OF THIS CORPORATION, SHALL HAVE THE RIGHT TO PURCHASE HIS PRO-RATA SHARE THEREOF (AS NEARLY AS MAY BE DONE WITHOUT ISSUANCE OF FRACTIONAL SHARES) AT THE PRICE AT WHICH IT IS OFFERED TO OTHERS.
